We Are Committed to Protecting Your Privacy

At Somatic Sanctuary, LLC ("Somatic Sanctuary") we respect your privacy. We know that it is important to you and it is a core value for us. We are committed to protecting any personally identifiable information that we may collect from you. Please read the following Privacy Policy to understand how your personal information may be collected, used, disclosed and stored.

Information Collected

We may collect certain personal information from you such as your name, address, phone number, email address and credit card information. This may be necessary to provide you with the products and services offered through our website. We will collect the minimum amount of information about you that we need to provide you with our offerings.

We may also collect information about your computer and web usage, such as your IP address, operating system, browser type, time and date of access. This allows us to analyze user behavior so we can improve our website. We do not collect any of your personally identifiable information across third-party Websites or online services. By your use of this website, you consent to our collection of your personal information.

Use of Information Collected

We do not share any of your personal information with other companies. We don't sell or rent our customer or email lists. We will only use this information to communicate with you about the services and goods you purchase from us, unless you sign up to receive our emails and newsletters.

We use the information collected on our website to update you on our products, services and offerings, and to provide you with marketing information, newsletters, or other information we think would be of interest

to you. In addition, if you make a purchase on our website, we may send you order and shipping confirmation emails. We will always give you the opportunity to opt out of receiving any of such materials.

You can remove your e-mail address from our e-mail list at any time by clicking on the "unsubscribe" link in any e-mail that you may receive from us. In addition, you can modify your information or change your preferences by contacting us as described at "Contacting Us" below.

Information obtained through our website may be intermingled with and used in conjunction with information obtained through sources other than our website, including both offline and online sources.

Technical Information

Like almost all web and mobile companies, we automatically record a variety of technical information when you use the our services:

- Log Data. Our servers automatically record information about your interaction with our products ("log data"), including information that your browser or your mobile app sends. This log data may include your Internet Protocol (IP) address, the address of the web page you were visiting before you came to the website, browser type and settings, the date and time of your request, and actions you take on the Website. We use this information to provide a version of the our services that will work in your browser. We also may use this information to diagnose and repair errors, crashes, and bugs so that we can improve our services.
- Cookies & web beacons. Like many websites, we use "cookies" (a small text file sent to your browser and stored on your device) or similar technologies. We use cookies so that, when you re-access the Somatic Sanctuary website, we can automatically log you in or populate the log-in fields for you. You can disable cookies through your browser, however, disabling cookies may limit your ability to use our services. A "web beacon," also known as an Internet tag, pixel tag or clear GIF, is used to transmit information back to a web server. We also may use third-party website analytics tools (such as Google),

- that collect information about visitor traffic on our sites and mobile applications.
- Device Information. We may collect information about the device you are accessing our website on, including what type of device it is, what operating system you're using, device settings, unique device identifiers, and crash data. We use this information to determine which devices to support and how to develop our services. We also may use this information to diagnose and repair errors, crashes, and bugs so that we can improve our services.
- Analytics. This information includes general usage information, and may include information such as the number and frequency of our visitors, which pages or features they have visited, which links on our website they have clicked on, and the length of those visits. We may also use third party applications and services, such as Google Analytics, to collect and analyze this information. We use this information to analyze and improve our services. We typically use this information in aggregate form, that is, as a statistical measure related to all of our users that would not identify you personally.

Disclosing Information

We will not share your personally identifiable information with third parties except as described below. We may, however, share aggregated statistical data with third party companies that does not contain any personally identifiable information.

We may disclose your personally identifying information in the following situations:

- (i) as required by law such to comply with a subpoena, or similar legal process;
- (ii) when we believe in good faith that disclosure is necessary to protect our rights or Somatic Sanctuary, protect your safety or the safety of others or investigate fraud;
- (iii) if we become involved in a corporate transaction, we will provide you with notice before disclosing any information or amending our Privacy Policy; and

(iv) to any other third party with your prior consent to do so.

We may be obligated to cooperate with various law enforcement inquiries. We reserve the right to disclose or transfer personal information and non-personal information about you and your activities on our Website in order to comply with a legal requirement or request from law enforcement or other government officials, administrative agencies or third parties as we, in our sole discretion, determine necessary or appropriate for the administration of justice, or in connection with an investigation of fraud, intellectual property infringements or violations of any other law, rule or regulation, our Terms and Conditions of Use or other rules or policies of our Website, the rights of third parties, or an investigation of any other activity that may expose us or you to legal liability, or to investigate any suspected conduct which we in our sole discretion deems improper.

Newsletters

If you have opted to receive our newsletter, you may cancel participation by following the instructions in each newsletter. We will honor all requests for list removal sent to us as described in "Contacting Us" below.

Protecting Children

We are committed to making a safe environment for children on our site. Due to the nature of the Internet, we cannot prohibit minors from visiting our website.
